

# NFED 40<sup>TH</sup> ANNIVERSARY SCAVENGER HUNT SWEEPSTAKES ("PROMOTION")

## OFFICIAL RULES

**NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN THIS PROMOTION. A PURCHASE OR PAYMENT WILL NOT INCREASE ODDS OF WINNING. PROMOTION VOID WHERE PROHIBITED.**

The Promotion is sponsored by National Foundation for Ectodermal Dysplasias ("**Sponsor**" or "**NFED**"), located at 6 Executive Dr., Ste. 2, Fairview Heights, IL 62208.

**1. Eligibility:** Promotion is open only to legal residents of the 50 United States and District of Columbia who are at least 18 years of age (or the age of majority in their state of residence, whichever is older) at the time of entry.

**2. Promotion Period:** Promotion starts at 12:00:00 a.m. Central Standard Time ("**CST**") on Monday, November 14, 2022 and ends at 11:59:59 p.m. CST on Sunday, November 20, 2022 ("**Promotion Period**").

**3. How to Enter:** To enter the Promotion, visit <https://www.nfed.org/scavenger-hunt> and follow the below steps during the Promotion Period.

(i) Answer all 10 questions correctly and submit your answers via the form provided on the website.

(ii) Include your full name and correct email address on your submission form.

By submitting an entry as instructed through the above method ("**Submission**"), you agree that your Submission conforms to the Guidelines and Restrictions below. Sponsor may choose to remove any Submission or disqualify you from the Sweepstakes if it believes that your Submission fails to conform with the Guidelines and Restrictions. Upon completion of all required entry steps and compliance with the Guidelines and Restrictions, you will automatically receive one entry into the Sweepstakes.

Limit one entry per person during the Promotion Period All entries must be submitted by the individual entrant. Bulk or automated entries will be disqualified (including, for example, entries made using any script, macro, bot, or promotional service). Any attempt to obtain additional entries through fraud or other illegitimate means will result in disqualification at Sponsor's discretion. If there is a dispute about the identity of the entrant, entries will be declared made by the authorized account holder of the email address associated with the account on which the entry is made.
